- No riding off the designated trail area and watering of horses in designated areas only
- No running of horses
- Note: For safety reasons, there may be few four wheelers on the trail (they will approach slowly and cautiously)
- Shod horses are strongly suggested

Directions: 23090 Round Valley Road, Paskenta. From Bartels in Corning, travel approximately 20 miles until you reach a "Y" in the road. Stay to the left. That is Round Valley Road. You will cross a bridge. Travel for 3.2 miles until you reach a white cattle guard on the right-hand side of the road. We will post a sign/balloons to indicate the road. Enjoy your day!

AGREEMENT & RELEASE OF ALL LIABILITY

I, _____, in consideration of the acceptance of this entry hereby acknowledge that I have voluntarily applied to participate in the Tehama County Cattlewomen Trail Ride (hereinafter referred to as "TCCW Trail Ride").

I voluntarily accept all risk of personal injury (including permanent disability and death), and property damage arising from my attendance and participation in the event.

In addition I hereby release and discharge the TCCW Trail Ride, the Tehama County Cattle Women (hereinafter referred to as TCCW) and Margie Kutz its officers, directors, members, employees, agents, contractors, guests, invitees, and affiliated entities, from any and all actions, claims or demands, that I, my heirs, personal representatives or assigns now have or may hereafter have for personal injuries or property damage resulting from my participating in the TCCW Trail Ride, and its members, employees, landowners, agents and contracting parties.
