6. Autobiography must also include the Following:
 - a) Further Education and Career Goals.
 - b) Applicant's Financial Ability to Meet these Goals.
 - c) Qualities of Good Character and Leadership Abilities.
7. Must Submit 3 Letters of Recommendation (To Be Included In Application)
From Teachers Or Employers (At Least One Must Be From A Non-College Source).
8. Please submit a photo with your application.
9. Award Monies must be Used Exclusively for School Expenses.
10. Interview with Sponsor Scholarship Committee will be part of the Selection Process.
11. Enrollment and Full Time Status must be verified by the College or University before the Award will be Funded.
