TCCW awards \$15,000 in scholarships

The Tehama County CattleWomen announce they have awarded \$15,000 among ten very deserving and accomplished Tehama County youth.

For 2018, the TCCW has added an Agricultural Vocational Scholarship given to those seeking an Agricultural Vocational Certification. Continuing scholarships awarded are the Ag Major Scholarship and Non-Ag Major Scholarship (for those of agricultural Families).

This year there were five Ag Major Scholarships, four Non-Ag Major Scholarships and one Ag Vocational Scholarship awarded. The Non-AG Major Scholarship Awardees are as follows: Jenny Mc Cluskey, Zakry Stroing, Rhylee Garrison, and Chelsey Bushnell. The AG Vocational Scholarship Awardee as follows: Daltyn Mc Caughey.

The top award for the Ag Major Scholarship, \$2500, was presented to Reed Pritchard. He is the son of Matt and Tessa Pritchard. Reed is a graduate of Red Bluff Union High School. He is currently attending Shasta College with the intention of attending Chico State University in Fall of 2019 to finish his Agricultural Business undergraduate degree before attending Law School.
